



RULES OF PROCEDURE - MOTOR HOME AREA

In accordance with the French Regional Authority Regulations a Motor Home area has been built on the rue du Docteur Heid in Munster. It is the responsibility of the Mayor to take any appropriate measures needed to prevent accidents and to keep good order, security and hygiene and to set local prices accordingly.

GENERAL POINTS

ARTICLE I: Parking on the motor home area, located on the rue du Docteur Heid in Munster, is reserved only for motor homes. It is therefore forbidden to other types of vehicle.

ARTICLE 2: The parking area is made up of 54 places. Parking on grassy areas is totally prohibited. To enable as many people as possible to enjoy the area, parking is authorized by sale of 1-day, 2-day, 3-day or one-week passes. It can be renewed. In case of heavy traffic, please be understanding and leave room for other motor homes.

ARTICLE 3: Parking, as well as certain services (unloading, electricity, tourist tax, water, access to sanitary facilities, washing station), are included in the package. Prices are set by deliberation of the city council. Users of these services are required to pay via the electronic pay point. The use of the petanque terrain, Wi-Fi and barbecues are free to users of the motor home area.

ARTICLE 4: The payment terminal only accepts payment by bank card (VISA or MASTER CARD, etc.) or by the "FLOWBIRD" application.

ARTICLE 5: Any fixed settlement or building is forbidden on the site, on the parking area, on common property or at any other place.

ARTICLE 6: Users are required to respect rules of good behaviour and road signposting in effect. The speed limit inside the area is 10 kph.

RESPONSIBILITIES

ARTICLE 7: Traffic and parking inside the area is the responsibility of the drivers and is at their own risk, just as on a normal road. Traffic and parking allowed inside the area will not be subjected to any security or surveillance contract. Users may use the area facilities at their own risk. This applies to equipment objects and belongings of the users. The City of Munster will not be held responsible for any damage to users or their belongings.

ARTICLE 8: Any person having access to the area is responsible for degradation he or she causes or caused by any person, animal or thing in his or her care. He or she will consequently be required to

make full reparation for the related damages. As a result, every user is requested to respect the facilities and will be held responsible for any damage caused.

USER RULES

ARTICLE 9: Pets are allowed, but they must be tied. Animals must be kept on a leash during walks. Their owners have to pick up their feces. Owners are asked to ensure that the peace of everyone is not disturbed.

ARTICLE 10: Barbecues, wood and coal fires are only allowed on facilities provided for the purpose. They are strictly forbidden on the bare ground or on parking spaces.

ARTICLE 11: Users are asked to respect each other and not to undertake harmful activities or disturb the neighborhood (noise, hygiene...). In addition, users must commit themselves to strictly comply with the rules of hygiene according to the applicable law.

ARTICLE 12: Each user is responsible for the cleanliness of his parking space. He or she must keep it in proper condition, as well as its immediate surroundings. Removal of sewage can only be made in the spots provided.

ARTICLE 13: Domestic waste, sorted beforehand, must imperatively be deposited in one of the containers provided, at the entrance of the site.

FACILITIES AND SERVICES

ARTICLE 14: A drinking water hydrant is in service in front of the area. It is made available for water tank recharge exclusively.

ARTICLE 15: The emptying of chemical cassettes must be made in the container provided. Next to the water hydrant, there is a trap on the ground where users can dump their waste water and which is connected to the sewage network.

ARTICLE 16: Electrical connections are only allowed on specific facilities provided. Each user getting his or her electricity supply from those facilities is requested to ensure the proper use and the security of his or her connection.

ARTICLE 17: The City of Munster may provisionally close the area for maintenance operations, and for safety or public interest.

ARTICLE 18: Any violation of the present Rules of Procedure will be recorded and the perpetrators will be prosecuted according to applicable laws and regulations.

<u>N.B.</u>: In case of emergency you have a call button located on the exit terminal. The latter will put you in touch with the on-call staff of the town hall.
